RESOLUTION OF NORTH GREENBUSH INDUSTRIAL DEVELOPMENT AGENCY ADOPTED ON CONSENT AT A MEETING DULY CALLED AND HELD ON OCTOBER 22, 2019

WHEREAS, the North Greenbush Industrial Development Agency ("NGIDA") was established in 1981 as a public benefit corporation of the State of New York—for the benefit of the Town of North Greenbush—pursuant to New York State General Municipal Law §927-a; and

WHEREAS, the NGIDA operates pursuant to Title One of Article 18-A of the General Municipal Law; and

NOW, THEREFORE, it is hereby RESOLVED:

- 1. That Terrence M. Moag, PO Box 762 Valatia, NY is the owner of two companies, The Radiant Store, and Zeroth LLC. The Radiant Store initially borrowed \$50,000 from the Town of North Greenbush IDA revolving loan fund on 12/01/2010. The note balance of \$32,649 was refinanced on 12/01/2016. The borrower has made consistent, on-time payments during the time he has had loans with the IDA.
- 2. That Terrence Moag has requested loan for Zeroth LLC in the amount of \$75,000.
- 3. That the Board of the Town of North Greenbush IDA, sitting as the loan committee, has reviewed the business plans, financial statements, background information, and personal financial statements for The Radiant Store, Zeroth LLC, and Terrence Moag and has considered this information along with the loan request.
- 4. The Board has approved the loan request from Zeroth LLC subject to the following:
 - a. The Radiant Store will repay the balance of the current loan.
 - b. Terrence Moag and Zeroth LLC will execute new loan documents including a promissory note, loan agreement, and personal guarantee.
- The Board has authorized Chairman Hurbanek to have documents prepared by the IDA attorney and to take any other actions necessary to facilitate the loan closing, including executing the required documents by signature.
- 6. The Board has authorized Treasurer Panichi to receive the loan payoff proceeds from The Radiant Store and to issue a check to Zeroth LLC in accordance with the loan agreement after all of the items in section 4 above have been satisfied
