2. A copy of the liability insurance and Worker’s Compensation insurance from the contractor, or if the homeowner is doing the work, a copy of the homeowner’s insurance and Workers Compensation form CE 200.
3. Picture or specs on the swimming pool/and or copy of brochure.
4. If constructing a deck, please see the DECK REGULATIONS on the website of the Building Department page. A sketch and a list of materials is needed at submission.

❖ PLOT PLANS SHALL INCLUDE:

- ❖ Show bordering roads
- ❖ Show existing structures with setbacks to property lines
- ❖ Show proposed structures (pool and/or deck) with setbacks to property lines
- ❖ The property line at roads is not the edge of pavement (measure from center of road to ½ the distance of the Right of Way [typical-50 ft R.O.W.]

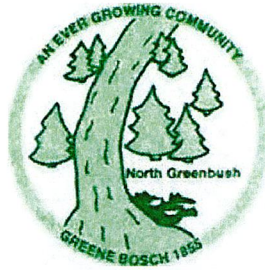

Swimming Pool Regulations/State Codes

- ❖ A Permit is needed for all swimming pools
- ❖ A PLOT PLAN is needed for ALL pools
- ❖ Flyer from swimming pool company is needed for file
- ❖ Above Ground pools with NO deck have a fee of \$50.00
- ❖ IN-GROUND swimming pools have a fee of \$100.00
- ❖ A TEMPORARY FENCE IS REQUIRED FOR ALL IN-GROUND POOLS PRIOR TO FILLING THE POOL & A PERMANENT FENCE IS REQUIRED WITHIN 30 DAYS OF FILLING THE POOL
- ❖ Insurance of the INSTALLER or homeowners insurance is required
- ❖ SENSORY pool alarm that has an IN-HOUSE monitor is required for all above ground and in-ground swimming pools
- ❖ If the above ground pool is over 24 inches high, a fence is required; if the pool is 4 feet or higher, no fence/barrier is required
- ❖ Above ground pool: Ladder or steps must be capable of being secured, locked or removed to prevent access
- ❖ In-ground pool: Must be fenced in, access gates must be self-closing and have self-latching device
- ❖ ALL pools must be 20 feet from property lines

SOFT-SIDE (or seasonal) swimming pools:

- \$50.00 for permit
- Picture of pool for file
- No insurance needed
- Ladder must be retractable/removable
- Pool sensory alarm is needed

NOTICE

BEFORE POOL IS USED

1. AN APPROVED FINAL ELECTRICAL INSPECTION must be completed by one of the following approved inspection agencies:
 - Commonwealth Electrical Inspection Service, Inc.: 518-238-2229
 - Middle Department Inspection Agency: 518-273-0861
 - New York Atlantic-Inland, Inc.: 518-857-6235
 - The Inspector, LLC: 518-481-5300
2. A permanent enclosure must be installed per Residential Code R326.4.2.
3. Any doors of a dwelling that service access to the pool must be equipped with an audible alarm per Residential Code R326.4.2.8.
4. A water surface alarm must be installed per Residential Code R326.7.1.
5. A self-closing and latching device must be installed on all gates per Residential Code R326.4.2.7.
6. A Certificate of Compliance shall be issued after an approved final inspection is completed.
