Supervisor Bott thanked Michael for his hard work and great job on his 1<sup>st</sup> budget as Town Comptroller.

# CONSIDER THE PROPOSED LOCAL LAW FOR THE "POINTS NORTH HOLDINGS, LLC REZONE APPLICATION"

Supervisor Bott called the meeting to order @ 6:31 pm. He asked everyone to rise for The of Allegiance, followed by roll call.

#### **DISCUSSION:**

Supervisor Bott opened the meeting by asking Ed Kleinke, Landscape Architect, to speak on behalf of Points North Holdings, LLC. The company filed an application on January 6, 2022 and then on March 14, 2022 the Town Board sent it to the Planning Board for review. On June 27, 2022 a summary of the project was given. The Planning Board sent their comments back to Town Board where in May the Town Board said they would ask for written comments and questions from the public.

Mr. Kleinke did a presentation showing all surrounding zoning in the area. He discussed the building size and location and the surrounding landscape. He briefly described the steps they are taking to store the hazardous chemicals. The process of hazardous waste removal and then the low traffic flow. Mr. Kleinke introduced Craig who explained the surrounding areas on the board they brought for visual. He read off the positive comments from the Laberge Group and Planning Board.

#### **COMMENTS:**

Supervisor Bott opened up the floor to public comment.

- 1.) Jim Greenfield, 555 Bloomingrove Drive, commented on the historical buildings and the area around the parcel in the neighborhood and opposed the zone change.
- 2.) Richard Fennelly, 548 Bloomingrove Drive, asked that the board not allow the zone change.
- 3.) Andris Lapins & Jean Muller 628 Bloomingrove Drive, started to pass out a Notice of Protect folder. The Town Clerk stated she gave each Town Board a packet that was dropped Tuesday at her office. The packet will be submitted into the permanent records of the Public Hearing. Andrew read off some information and voiced his concerns and both were against the zone change.
- 4.) Mike Myers, Evergreen Lane, he supports the no rezone for the parcel and feels the Superfund sites from the EPA was no very clear.
- 5.) Mary Frances Sabo, 40 Buckbee Road, stated that the Town did a rezone 6 years ago and this felt like Spot Zoning. She stated she is not against development, but is opposed to this rezone request.
- 6.) Robert Bolt, 3 Walker Avenue, owner of a multi-family home. Concerned about the drinking water, his multi-family home is on a well and it's directly next to this site. He is opposed to the rezone at this location.
- 7.) Andy Mair, Defreestville Town of North Greenbush. Mr. Mair handed out the Notice of Protest that the clerk had given to the board in their packets, he wanted to have it submitted into the permanent record. He stated that this vote would have to have 20% or more to pass and that with 5 board members, 4 yes's were needed to pass. He read from the June 28<sup>th</sup> memo from the Planning Board. He felt that this was Spot Zonin. He handed out the definition of Spot Zoning to the board. The Town Attorney asked for the Clerk to receive whatever he passes out to the board for the record. He stated that it was in the Notice of Protest, so the Town Clerk already has the paperwork he gave the board.

He mentioned Resolution 2022-10-59 and 2011-10-60. He hopes that these resolutions are not already judged and determined, as they are on the Regular Board meeting agenda following this Public Hearing. He hopes he has changed the minds of the town board members about this rezone. He is opposed to the rezone. He stated 5 reasons why the board should vote no to the rezone.

After all public comments Mr. Kleinke addressed their comments of the night. He continued with discussing the NYSDOT low 3% increase in traffic. He continued into the building designed which is for interior service, with no outside service area for cars. They will look into a special area for drop off of vehicles outside the building. He wanted to make it clear that this is not Spot Zoning because of the surrounding area has commercial type and specialty businesses in the area. Everyone in this area has a personal need to drive, which is why this parcel is perfect. Craig then spoke about the comments on Spot Zoning; he wanted to make sure that the board was aware that this is not a Spot Zone request. Look at the surrounding uses; PDD, General Business Neighborhood. The comments that were on site plan concerns will be addressed by the Zoning Board.

Supervisor Bott asked if the board had any questions, Councilwoman Hoffman asked about the run off comments and spillage. Mr. Kleinke said there is an inside containment system and a disposal system of all hazardous chemicals. The roof has a Storm Water plan. Bloomingrove Drive & Washington Avenue have storm water drains, there is no hazards if it rains, as it is already in place.

Mr. Andris Lapins spoke again stating he is a retired Hydrogeologist, which is stated in the packet the Town Clerk received, and he wanted to make sure they were aware of the accidental hazards that could happen. He stated Mr. Kleinke kept mentioning the inside waste hazards, but what about the outside and our wells.
