Discussion:

Supervisor Bott introduced John Frazer, Senior Managing Engineer for Barton & Loguidice. (Attached is the paperwork from his presentation).

There were a few questions and answered that occurred at the meeting below:

Michael Martinez asked who was paying for the project, John stated all 1.6 million is being paid for by the County.

Dave Wilson asked about the hydrants and the set ups for fires. John answered that they will all be up to date and ready for fires.

Councilperson Hoffman asked why it was stopping at 88 Macha Lane. John answered because that is where the water district ends.

Councilperson Gordon wanted John to discuss the pressure incr4ease that will occur. John stated that the increase would be ¾ more than it is now. Flow will increase almost immediately when the system is complete.

David Wilson asked if it would increase the area to 150 and Snyders Lake Road as years ago we had a fire there on the corner and pressure was an issue. John answered that it would, and there will be flow tests done in each area.

Supervisor Bott asked if it would be connected to Poestenkill, John stated it will not be as the water district ends there.

Councilperson Gordon when will the project be ready, John answered the end of this month and should be awarded in December.
