WHEREAS, the Town Board recommends entering into an agreement with HTI3 Carnival (the "Amusement Vendor") for the provision of such services, whereby the Town receives a percentage of the revenue derived by the Amusement Company for its services provided plus a concession fee per day; and

WHEREAS, it is necessary for the Town Board to authorize the Town Supervisor to execute the agreement on behalf of the Town; and

WHEREAS, it is in the best interest of the Town to require the Amusement Vendor to provide adequate insurance coverage, including naming the Town as an additional insured, to protect the Town from potential liabilities, and proof that the rides have been properly inspected;

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of North Greenbush as follows:

- 1. That the Town Supervisor is hereby authorized to execute an agreement with the Amusement Vendor for the provision of certified amusement rides and related services at the Town Fair to be located at Town Hall, 2 Douglas Street, Wynantskill, New York from September 5-7, 2025, the terms and conditions of which shall be subject to the approval of the Town Attorney.
- 2. That the agreement shall include a provision requiring the Amusement Vendor to obtain and maintain commercial general liability insurance in the amount of at least \$2,000,000 per occurrence, together with a contractual indemnity clause covered by said insurance; all deemed appropriate by the Town Attorney, naming the Town of North Greenbush as an additional insured.

3. That Amusement Vendor shall, prior to the date of the Town Fair, provide the Town with a certificate of insurance demonstrating compliance with the insurance requirements set forth in the agreement and proof that the rides have been properly inspected and deemed safe.
