Section 175-34. Schedule IX: Parking Prohibited

Section 175-34, Schedule IX of the North Greenbush Town Code entitled "Parking Prohibited" is hereby amended to add the following in alphabetical order:

Section I. Section 175-34 of the North Greenbush Town Code is hereby amended to include:

No parking on Bloomingrove Drive at the intersection of Bloomingrove Drive and US Route 4 (North Greenbush Road) to the intersection of Bloomingrove Drive and Washington Avenue Extension. This prohibition applies to both sides of the road.

Section II. This Local Law shall take effect immediately upon filing it in the Office of the New York State Secretary of State.

Section III. The law supersedes section 175-34 of the North Greenbush Town Code to the extent inconsistent therewith.

- 3.) Bloomingrove Development LLC. shall provide cash or an irrevocable letter of credit or a surety bond in the amount of \$30,000.00 to secure completion of the work outlined in the attached letter prepared by Eric Westfall, PE dated September 19, 2025. In addition, Bloomingrove Development LLC shall provide an executed Security Agreement which requires them to complete the work outlined or which enables the Town to access funds to complete the work if they fail to do so.

AND IT IS FURTHER, RESOLVED that this transaction will be deemed complete after the Town has received all the items required by the resolution and the same have been reviewed and approved by the Town Attorney and Town Engineer. The Town will not be maintaining the roadways and other infrastructure until this transaction is completed.

In the Matter of Defining What Constitutes the Submission of a "Substantially Complete Building Permit Application"

WHEREAS, New York State enacted the All-Electric Building Act (the "Act") which is effective January 1, 2026; and

WHEREAS, the Act prohibits the issuance of building permits for new buildings under seven (7) stories that are not all electric if the initial application for building permit is submitted after December 31, 2025; and

WHEREAS, the Department of State Building Codes Council issued final rules on the implementation of the Act, and under those rules, after December 31, 2025, the only project eligible for a gas connection will be those that either: (i) already hold a valid building permit, or (ii) have submitted a "substantially completed building permit application"; and

WHEREAS, whether an applicant has submitted a "substantially completed building permit application" is within the judgment of the Town; and

WHEREAS, the Town intends to provide an administrative clarification for the North Greenbush Building Department by establishing the minimum criteria under which an applicant will be deemed to have submitted a "substantially completed building permit application"; and

WHEREAS, the Town's Building Inspector, Engineer and Code Enforcement Officer have provided guidance on said criteria; and

- 6. payment of a fee of \$100.00 (all other regular determined building permit based on a fee per square foot, water and sewer permit fees and water meter fee will be due ten (10) business days prior to the commencement of construction); and be it further

RESOLVED, that the foregoing requirements, in the opinion of the Town Board, shall constitute a "substantially complete building permit application" as defined in Part 1240 of the Energy Code in compliance with Part 1203.3 of the Uniform Code and the Energy Code.
