The Goal for the Town is to better educate the public on water quality and control measures. This is accomplished through open discussions with the public at Town and Planning Board Meetings and Public Hearings related to SWPPPs, inspections and Stormwater BMPs. Items are posted at the Town offices and the Town is moving toward posting stormwater documentation and guidelines on a Town web page dedicated to SWMPPP issues (anticipated completion Fall 2020)

B. Briefly summarize the observations that indicated the overall effectiveness of this Measurable Goal.

The Town saw several high-intensity stormwater events during 2019. As a result, the public was far more involved in learning about the review, inspection and remediation procedures for construction stormwater management, attended a great deal of public meetings, and engaged in open and active discussions. Additionally, the Town has begun to form several committees related to many items occurring in the Town (including SWMPP), and members of the public are joining these committees.

Building and Highway personnel regularly inspect stormwater systems and outfalls within the Town. Inspections are conducted during low flows and after high discharges such as heavy storms or during the spring thaw. Additionally, construction sites are regularly reviewed and inspected (wash-outs, fueling, etc). The Town is continuing a policy of being proactive, rather than reactive, to illicit discharges.

The Town continues to find very few, if any, illicit discharges during inspections. It is assumed that a combination of education, monitoring, and a proactive stance (expression of expectations to construction personnel, e.g.) has helped to minimize illicit discharges through either human error or the failure of a system component.

To achieve the Goal of better construction site runoff control, the Town has established a pre-construction kickoff meeting policy with contractors to review the SWPPP requirements, individual training certifications, inspection roles and responsibilities, and the maintenance or upgrading of SWPPP measures.

B. Briefly summarize the observations that indicated the overall effectiveness of this Measurable Goal.

The Town has seen a reduction in construction site runoff through the installation, inspection and maintenance of countermeasures such as silt fencing, mulching, stabilized construction entrances, staggered construction activities, and other BMPs. This is evidenced by a reduction in the number of questionable items noted during self, reconnaissance, and comprehensive inspections conducted by the Town, the Town's agent, or the contractor's self-inspection individual.

The Town manages stormwater quantity and quality for Municipal Operations by having the Highway Department sweep roads and municipal parking lots three to four times a year, reclaiming salt in the spring, inspecting and cleaning catch basins as required, maintaining stormwater management systems, and conducting maintenance on infrastructure (stormwater and otherwise) as necessary.

The Town has noticed an increase in the quality of municipal operations stormwater quality discharge (lower turbidity) and a reduction of stormwater volume, as measured by flooding (even during a year with several large storm events) as a result of the practices outlined above.
